

#### Requirements

Original fashion design works with creativity for women, men or children (age 5 or 6)

- \* It must be unpublished and uncreated.
- \* There are no restrictions on the category (i.e., entries can be for any season, formal or casual), or the number of works you can submit.
- \* Even in unisex design, please select the category assuming the wearing model.
- \* If you don't select a category or select multiple categories, the contest organizer will decide a category.

#### Application Qualifications

The contest is open to everyone (but participation by group is not permitted).

You must be able to create works based on the design sketch, and attend the final public judging and rehearsal the day before in Nagoya City at your own cost.

#### Judging Criteria

Expressiveness, originality, and quality of finish

#### Application Method

By referring to sample layout, produce a design sketch (only original) on a B4-size  $(257\times364 \text{ mm})$  sheet of drawing paper.

Complete a design description form and an application form, and attach them to each sketch.

You may attach fabric-swatches, and other related images (taken or created yourself or non-copyrighted) on the same sheet as necessary.

\* Please don't use AI, copyrighted photos, images of art work, etc.

#### Application Fee

- 1) If you send sketches from outside Japan, application fee is waived.
- 2) If you send sketches from Japan, you need to pay 500 yen for each sketch as application fee by "Kogawase" of Japan post office. \*Please don't fill anything in "Kogawase".
  - \*Cash or stamp will not be accepted.

#### O Deadline for Submissions

Submissions must be received to Nagoya Fashion Association not later than **Thursday, May 15, 2025** by post or courier.

- \*Submissions after the deadline will not be accepted.
- \*Submissions via e-mail will not be accepted.
